



## Notice of Stakeholder Meeting for Gold Standard Retroactive Accreditation of Hebei Shangyi Manjing West Wind Farm and Hebei Shangyi Manjing East Wind Farm Projects, China

Date: 7 Oct 2008

A Stakeholder Meeting for Gold Standard retroactive accreditation of Hebei Shangyi Manjing West Wind Farm and Hebei Shangyi Manjing East Wind Farm Projects will be held on 16 October 2008. The stakeholders are all the individuals and organizations which may be impacted by the Projects, and include local residents, government offices, environmental protection agencies and non-governmental organizations (NGOs).

During the meeting, a briefing about the processes of the Clean Development Mechanism (CDM) and the Gold Standard retroactive accreditation will be presented to all the participating stakeholders. The meeting will serve as a platform of communications where all stakeholders will be welcome to participate and give comments. ### **Non-technical Summary of the Projects:**

The Hebei Shangyi Manjing East Wind Farm Project has been developed by Guohua (Hebei) Renewable Energy Co. Ltd, and is located nearby Manjing in Shangyi County, Hebei province, P.R.C. The 49.5 MW wind farm has 33 wind turbines, each with a rated power output of 1,500 KW. It was registered as a CDM project on 31 March 2007 and is in operation now. The project has an average annual electricity output of 116,820 MWh, using wind power resources.

The Hebei Shangyi Manjing West Wind Farm Project has also been developed by Guohua (Hebei) Renewable Energy Co. Ltd, and is located nearby Manjing in Shangyi County, Hebei province, P.R.C. The 49.5 MW wind farm has 33 wind turbines, each with a rated power output of 1,500 KW. The project started construction in July 2006 and is currently in operation. It has an average annual electricity output of 103,000 MWh, using wind power resources.

Both projects have improved air quality when compared with the baseline scenario by reducing other pollutants which would have been emitted by the power generation industry. They have also improved local livelihoods and promoted the development of the sustainable renewable energy industry in China.
